CERTIFICATE OF INCORPORATION

Certification of incorporation of INTERNATIONAL  
TAPE ASSOCIATION, INC., pursuant to the Membership Corpora-  
tion Law.

We, the undersigned, for the purpose of forming a mem-  
bership corporation pursuant to the Membership Corporation Law  
of the State of New York, do hereby certify:

1. The name of the proposed corporation shall be  
INTERNATIONAL TAPE ASSOCIATION, INC.
2. The purposes for which it is to be formed are: To  
provide members with a source of information regarding  
innovations in the tape and cassette business; to pro-  
mote, cultivate and foster among its members an under-  
standing of the tape industry, musical, visual and  
otherwise for all purposes and all uses now known and  
hereafter to become known, and to accumulate and dissemi-  
nate information, and to promote within the industry  
a professional attitude and to aid in the instruction,  
promulgation among its members of full knowledge and  
understanding of the industry as now comprised and all  
future developments technical and otherwise by and

through which the public and the industry would benefit.

Nothing contained in this Certificate shall authorize or empower the Corporation to perform or engage in any act or practice prohibited by Section 340 of the General Business Law or other anti-monopoly statutes of this state.

3. The Territory in which its operations are principally to be conducted is the continental United States.

4. The City and County in which its office is to be located is the City of New York, County of New York.

5. The number of its directors shall be not less than three (3) nor more than eleven (11).
